Barrett Boat Works, Inc. (BBW, The Marina) agrees to provide and you agree to accept and pay for the requested services.

Furthermore,

1. This agreement is for storage only. Space to be used at the sole risk of the owner. Barrett Boat Works Inc. is not responsible for theft or damage of any kind to boat or its contents.
2. BBW may move boat to other storage space at any time. Storage term is from approx. Oct. 1, 2019 to May 14, 2020 (dates subject to change). **Summer storage fees may be applied to all boats not picked up before May 14th. After May 14th boats can only be picked up Monday through Friday with 24-hour notice.**
3. Working on your boat in the storage building is permitted on a VERY LIMITED basis only. NO sanding, painting, use of a buffer, or use of any power tools is permitted. Violation of this policy will prohibit further access into boat storage areas. Hours are 8 am – 4 pm, Mon – Fri.
4. Any boat moved outside at customer's request will be subject to a moving fee.
5. No warranty as to the condition of ramps, ladders, or walks. Not responsible for injury occurring to persons or property.
6. No outside labor is permitted on premises unless granted by written permission of Barrett Boat Works Inc.
7. No boat will be stored without a signed agreement.
8. Exterior attached equipment (downriggers, antennas, outriggers, etc.) must be lowered or removed for storage. Barrett Boat Works Inc. is not responsible for these items. Disassembly and reassembly of these items will be charged \$50 per hour. Customer to furnish boat in storable condition.
9. THE BALANCE OF ALL STORAGE AND WINTERIZATION FEES ARE DUE UPON RECEIPT OF YOUR INVOICE. A MONTHLY SERVICE FEE OF 2% WILL BE ADDED TO ALL UNPAID BALANCES.
10. There is a \$250 non-refundable deposit is due by August 29, 2019 to reserve your storage.
11. Barrett Boat Works requires vessel fully insured by its owner. Barrett Boat Works is not liable and assumes no responsibility to the owner for loss or damage caused by fire, the elements, heat, cold, frost, rust, unlawful disturbance of the peace, riot, vandalism, etc. The Marina shall not be liable for its own negligence and/or negligent acts causing any loss or damage to the vessel by fire or elements unless said loss is due to the Marina's gross negligence. Owner shall further understand and agree that the Marina is not responsible for any scratching, gouging or abrasions of any kind or nature unless due to the Marina's gross negligence. Barrett Boat Works does not carry insurance to cover this risk. To the extent permitted by law, customer waives any right on the part of his or her insurer against Barrett Boat Works, Inc. and its employees, agents and servants by way of subrogation or assignment for loss or damage to property no matter how caused.
12. No "For Sale" signs permitted on boats while in storage.
13. Notice of Storage Lien. Barrett Boat Works Inc. hereby provides notice that it will claim a lien on the boat for storage fees pursuant to the Michigan Marina and Boatyard Storage Lien Act. The Act permits Barrett Boat Works to retain possession of the boat until the storage fees are paid in full. If the payment of the storage fees are more than 180 days in default, Barrett Boat Works may enforce the lien by selling the boat at a commercially reasonable public sale under the terms set forth in the Act.
14. The boat owner will be responsible for the legal expense, or whatever means necessary in collection and enforcement of this agreement.
